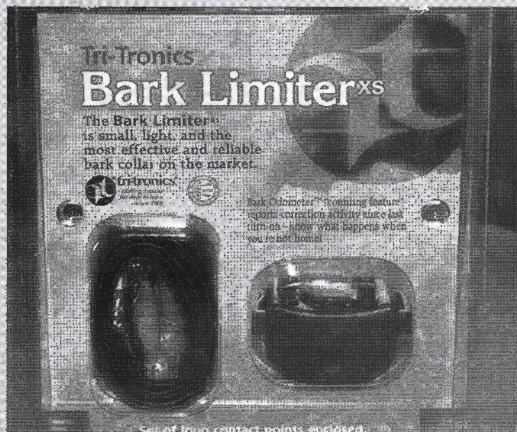
Tri-Tronics® Bark Limiter

When dogs are kenneled outside, it is important to make sure they are not barking when you are not home. Most people think their dogs don't bark while they are away, when just the opposite is true. It's in their nature and while a little bit of barking is tolerable, nuisance barking is not.

Now, Tri-Tronics® has a new bark collar that works great. It is called the Bark Limiter. This collar is different than most others on the market for two reasons. The first, and most unique, is that there is a counter on it. When you turn the collar off at night, a small LED light flashes for every time the dog received a correction. The second is that it stimulates the dog every time it barks with no delay or grace period. Some other collars have a rest period that after a dog barks, and will not apply stimulation for 10 seconds. Many dogs will figure this out in time, and will bark once, then wait nine seconds and bark again there is no cheating. The counter also makes it easy to set the level of stimulation for your dog's temperament.

When you take the collar off at night and find out that your dog barked 20 times while you were gone, then you need to go up one more level. Keep going up a level at a time until you get the results you're looking for. There are five levels of stimulation; I will start young dogs at level two, older dogs on level three. Most dogs won't bark on level four, and I have yet to find one that needed level five.

The collars have a sleep mode, so after you get the level set for your dog you can take the collar off and set it down without running the battery down. This helps preserve the on-off switch. I have used three different brands over the years and this one is by far the best one I have ever used.
